ORDER:

In the reference read above, the Principal Chief Conservator of Forests, Telangana, Hyderabad has submitted that "*Telangana Ku Haritha Haram*" is a flagship programme of the Government envisaging massive afforestation for increasing the green cover of the state. The programme requires continuous monitoring and ensuring coordination among various agencies for successful implementation of the programme. Therefore, the PCCF, Hyderabad has requested the Government to consider for constitution of District Level and State Level Monitoring and Coordinating Committees for continuous monitoring of the progress of implementation of *Telangana Ku Haritha Haram* Programme.

2. Government after careful consideration of the proposal of the Principal Chief Conservator of Forests, Telangana, Hyderabad, hereby constitute the District Level and State Level Monitoring and Coordination Committees for continuous monitoring of the progress of implementation of *Telangana Ku Haritha Haram* Programme as detailed below:

**I. District Level Monitoring and Co-Ordination Committee:**

The District Level Committee will meet once in (15) days and review the progress of nursery raising and allied works and send reports to the Prl. Secretary to Govt., EFS&T Department, Prl. Secretary to Govt. Rural Development, Prl. Chief Conservator of Forests (HoFF) and Commissioner, Rural Development every fortnight. The committee will also plan for planting, selection and finalizing planting areas and monitor the planting in the planting season.
