ORDER:

Government of Telangana have launched an ambitious project of greening the State, with the name "*Telangana Ku Haritha Haram*", a flagship programme with a target to plant 230 crore seedlings in 3 years, duly involving all the Govt. Departments, Local Bodies, Corporations and all the stakeholders of the society.

2. In the G.O. 2<sup>nd</sup> cited, Government have constituted the District Level and State Level Monitoring and Coordination Committees for continuous monitoring of the progress of implementation of *Telangana Ku Haritha Haram* Programme. These Committees are monitoring the programme at District and State Level, respectively, with all the concerned officials.

3. Considering the target for the year 2014-15, and to give clarity of roles and responsibilities of the line departments, including budgetary support, there is need to review Haritha Haram programme. Hence, it is necessary to constitute a State Level Steering Committee for effective decision making related to *Telangana Ku Haritha Haram*.

4. Accordingly, Government hereby constitute the State Level Steering Committee with the following composition:
